RCT WIOA Combined State Plan (CSP) Modification, Matt Berend, Program Specialist for VR

- The RCT has reviewed and provided feedback to the modifications.
- The RCT feedback is currently being reviewed and incorporated.
- The final master draft should be ready next week and be sent back to RCT for final review.
- TWC VR will brief with TWC Executive Management.
- The plan will be delivered to TWC Commission in January.
- In February a 30 day public comment session will be held.

- Then back to TWC Commission, then to the Texas Workforce Investment Council and then off to the Texas Governor for approval.
- Final step the plan will be sent to the federal partners.

VR Grant Presentation 101, Cheryl Fuller VR Director

- Mrs. Fuller provided a PowerPoint presentation on the VR Grant process and updates followed by discussion.

RCT Committee Reports

- Customer Satisfaction and Needs Assessment, Gennadiy Goldenshteyn, Chair
 - Customer Satisfaction Report for Q4 was reviewed by the committee. The report covered data from June through August 2021. An area that continues to struggle is choice of provider.
 - VR Performance Update was reviewed by the committee. This includes employment outcomes.

- The survey is lacking in responses from closed case responses. So, committee is recommending adding further survey channels not just phone calls but add email, texts, web-based surveys.
 - Chris Speckhard provided compared earnings data and the committee requested a comparison of this report verses the state average. The requested information was provided to the committee.
 - Remote access was another topic discussed. Further education and support for the customer is needed in this area. The committee highly recommended to continue to provide a mix of in-person and remote services moving forward.
- Education and Membership, Michael Ebbeler presented on behalf of Bobbie Hodges, Chair
 - Membership Update
 - The council received appointments and reappointments in October. The membership is in compliance.
 - Training for future RCT meetings
 - RCT Member Mentorship program is close to implementation.
 - New Member Orientation was held via Zoom on December 1.
- Policy, Procedure & Personnel Development, Karen Stanfill, Chair
 - New members to the committee were introduced and provided with an overview of the committee duties.
 - Comprehensive System of Personnel Development
 - VR Counselors (VRC) positions, 429 of these meet the CSPD requirements and 200 plus are in the process of obtaining a master's degree. A discussion was held about the new process that a counselor one cannot be promoted to a counselor two until they have at least applied and been accepted into a master's program

- Discussion was held about the VRC positions that have been vacant for over five months. TWC will be working with a recruiter. There is a salary increase which should help. The committee recommended that TWC recognize the VRCs maybe at the conference.
- Policies
 - The committee request TWC VR provide them with a copy of any guidance memos that affect policy.
- Training
 - Tammy Shaw from TWC VR has been hired as the Training Manager.
 - Counselor training is being updated.
- IHO there were 2 IHOs to review. Due to time limitations these were not reviewed at this meeting but will be reviewed as a later time.
